Corrigendum No. 3 to IFB No. CPI4058P20

EPC and O&M Tender Package for Construction of Water Injection Stations at WIS#GCS-6 & WIS#21 in Duliajan, Dibrugarh District, Assam

1. This Corrigendum is issued to notify the following:-
 - i) Various changes/modification to be incorporated in various parts of the tender is notified as per the attached **Annexure-I**
 - ii) Revised format for declaration of Concurrence Commitments for evaluation of Bid Capacity in BEC/BRC is attached herewith as **Annexure-II**
2. All other terms and conditions of the tender remain unaltered.
3. All the prospective bidders are requested to regularly visit OIL's Website: www.oil-india.com and e-procurement portal <https://etender.srm.oilindia.in/irj/portal> for further announcements/latest information related to this tender.

This corrigendum has been published to notify following changes/modification incorporated by OIL in various parts of the tender:

- A) In VOLUME-II PART A SECTION-A12 of the Tender : “PERFORMANCE GUARANTEES, TESTS & PENALTIES” Clause no 2.0 (Page no 85 of 713) shall be read as:**

CATEGORY "A" GUARANTEES

| 5 | pH of Injection Water (at Water Injection Pump Suction Header) | 7.5 to 8. |

Tests in this category shall be performed as per the relevant testing codes specified in this Tender.

- B) In VOLUME-IV PART 3 of the Tender: (Page no. 6 of 73)**

In “EQUIPMENT LIST - WIS#21 (Document no. 18039-M-LL-0503)”; capacity/liquid flow rate of Water Injection Pumps P-4000 A/B/C/D shall be read as 22 m3/hr in place of 31.5 m3/hr.

- C) In Vol-II- Part B (Page 175 of 713) of the Tender: Clause no 2.0 a) shall be read as under:**

2.0 a) “Reciprocating Pump package shall include Pump, Motor drive system, Gearbox, coupling with non-sparking guard, safety valve, pulsation suppression device, instrumentation, control panel and other items necessary to make the unit operational. Each Reciprocating Pump package shall be mounted on a common Base plate to handle treated produced water from ETP Tengakhat/ ETP at STF Madhuban. Exposed moving parts shall be enclosed by an adequate guard for personnel protection.”

- D) In Vol-II Part B (Page 178 of 713) of the Tender: the clause no 4.0 c) shall be read as under:**

4.0 C) “After determination of pump performance curves, the pump shall be run continuously for 24 hours at rated head using ordinary water.”

- E) Special Note to all Bidders:** Bidder to submit the list of mandatory spares to be provided as per the quoted **Diaphragm type seal-less reciprocating pump** (Water Injection Pump).

- F) In Vol-I, Part-1 of the Tender (Page no. 28 of 206); Sub Clause no. 8.6 under Clause No. 8.0: BID PRICES shall be read as under:**

“The Owner (OIL) is entitled to get the benefit as per Clause 57.2 of SCC of this Tender and accordingly the bidders are advised to assess the requirement of any Imported Goods for the proposed project job. The Bidders are required to load the applicable Customs Duty in their quoted price on the basis of their assessment with the sole motive of quality and sustainability of the material to be used in the project job. However, the IGST on the imported goods will be on OIL's Account. In case after award of the tender, OIL cannot arrange

the Essentiality Certificate (EC), the reason not attributable to the Bidder (Contractor), then the Customs Duty paid by the Bidder at the time of clearance of the goods will not be reimbursed by OIL.”

The reply to queries of the bidder are as under:

1. In case OIL issues EC, the bidder (contractor) will refund the customs duty amount ONLY as per Bill of Entry to OIL.
2. In case EC is not issued by OIL, no action is required from the contractor or from OIL.
3. For other queries, Bidders to be guided by the below mentioned clarifications cited in **Sl. No G.**

G) In Vol-I, Part-3, Section III-SCC of the Tender (Page no. 122 of 206):

Ref Sub Clause 57.2: “NIL Customs Duty & Concessional GST Applicable for Projects in ML/PEL Area”, below clarifications have been issued for better clarity to all the bidders.

OIL will issue EC subject to the following conditions:

1. The import has to be in the name of OIL so that the benefit of NIL custom duty and concessional GST comes to OIL directly. In that case, the customs duty will be NIL and IGST @ 5% and other applicable levies will be payable at the time of clearance of goods from the customs by the bidder (Contractor).
2. Billing for the imported item has to be done exclusively as per Bill of Landing, Bill of Entry and other shipping documents enclosed therein with the Invoice. The payment of import value along with 5% IGST and other levies paid during clearance of goods will be borne by OIL.
3. The value of imported items will not be part of milestone base payment schedule and it will be shown separately in the billing schedule.
4. The GST for imported items will be IGST @5% and for other items along with the services in the contract will be @ 18%.

H) In Vol-I, Part-1, ITB of the Tender (Page no. 44 of 206) shall be read as under:
